14. No recording or broadcasting of any type is permitted without prior written consent of Purchaser.
15. Purchaser retains the right to use the Artist, Band and their music in promotions of this event as well as future events.
16. Artist is expected to fulfill all obligations Rain or Shine.
17. In the event Purchaser must cancel the show due to "unsafe weather" conditions, "acts of God", riots, acts of terrorism, or other legitimate conditions out of Purchaser control, Artist will not be entitled to full compensation.
18. If RIDER is required by band, the rider must be agreed upon and signed by both parties before it is included as part of this contract.
